2009 Team Camp Important Reminders:

1. Entry fee balance due - **Friday, June 5th** (\$150 Total per team).

Waiver of Liability, Assumption of Risk & Indemnity Agreement

Waiver: In consideration of being permitted to participate in any way in

hereinafter called "The Activity", I, for myself, my heirs, personal representative or assigns, **do hereby release, waive, discharge, and covenant not to sue** The Regents of the University of California, its officers, employees, and agents from liability from any and all claims including the negligence of The Regents of the University of California, its officers, employees and agents, resulting in personal injury, accidents, or illnesses (including death) and property loss arising from, but not limited to, participation in The Activity.

Assumption of Risks: Participation in The Activity carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from 1) minor injuries such as scratches, bruises, and sprains 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions 3) catastrophic injuries including paralysis and death.

I have read the previous paragraphs and I know, understand, and appreciate these and other risks that are inherent in The Activity. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

Indemnification and Hold Harmless: I also agree to INDEMNIFY AND HOLD The Regents of the University of California HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in The Activity and to reimburse them for any such expenses incurred.

Severability: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledgment of Understanding: I have read this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and **understand that I am giving up substantial rights, including my right to sue.** I acknowledge that I am signing the agreement freely and voluntarily, and **intend by my signature to be a complete and unconditional release of all liability** to the greatest extent allowed by law.

TEAM CAMP DIRECTIONS

Directions to Events Center AKA "Thunderdome"

If you are **Southbound** on Highway 101:
Exit Storke Rd/Glenn Annie (Turn right onto Storke Rd)
Go straight 1-1.5 miles
Forced left turn onto El Colegio Rd
Go straight 1 mile which will take you onto UCSB Campus.
The EVENTS CENTER will be on your right as you proceed through the second light.

If you are **Northbound** on Highway 101:
Take WARD MEMORIAL BLVD/Hwy 217 off of Hwy 101
Follow 217 onto campus and merge right onto Mesa Road
Take a left at the third stop light onto Ocean Road.
Take a left at the second stop light and the Events Center will be on your right hand side.

Directions to Tropicana Gardens

6585 El Colegio Road – Goleta, Ca 93117

If you are **Southbound** on Highway 101:
Exit Storke/Glen Annie (Turn right onto Storke Road)
Go straight for 1-1.5 miles
Forced left onto El Colegio Rd.
Tropicana Gardens are Approx. 2 miles down El Colegio on the right hand side

If you are **Northbound** on Highway 101:
Exit Los Carneros and turn left
Follow the road until it ends (1-2 miles)
Turn Left onto El Colegio Rd.
Tropicana Gardens will be on your right hand side

If you are **Southbound** on Highway 101:
